HOW TO USE

DO NOT spray when conditions are hot, or when soil is dry and plants are suffering from moisture stress. The best time to apply is in the late afternoon.

HOW TO PREPARE

Add required amount of eco-caterpillar killer DiPel into about half the required amount of water, agitate, then pour the rest of the water on top and shake or stir till thoroughly mixed. Do not mix more spray than is needed.

It is important to spray both sides of all foliage. Respraying at 5-7 day intervals may be needed as more caterpillars hatch or under rainy conditions.
